### THE ESTA WORKING GROUPS

CIT EU LAWS AND RELATIONSHIP The Services Directive (draft) initially provided for a derogation to the Country of Origin Principle, to our industry, until 2010 or instrument of harmonization. The European Parliament, under social pressure, has amended the Commission proposal and excluded all private security services from the scope of the Directive; our drafted derogation is automatically deleted.

The Country of Origin Principle is enshrined in the EU treaty and an exclusion from the scope of the Directive will result in a vertical Directive for all private security services. The Commission will table a counter-proposal by April/May 2006.

- CASH GROUP (FORMERLY CENTRAL BANK GROUP)
  - ESTA is commissioning an academic survey on the cost of cash; this paper will be presented to our ESTA Conference.
  - ECB is currently conducting a analysis of cash efficiency and this document should be completed within 6 months.
  - The National Bank of Belgium has published a remarkable document on the costs, advantages and

disadvantages of different payment methods. This document is available from our secretariat and concludes that the possible savings by substitution of fiduciary money by debit cards, chip/pin and credit cards, are limited to only 0,02% of GDP.

 Those documents and your support will be essential to rebut the "cashless society" thesis and similar ideological concepts defended by credit card companies, several banks and European authorities

#### > CIT SECURITY AND RISK MANAGEMENT

- CEN TC263 Standardization attempt is temporarily suspended by unanimous decision of participants This decision is motivated by CEN time constraints, some security issues and other uncertainties, such as future banknote substrate.
- The following working group priorities have been approved by the Board:
  - Use of weapon in the industry;
  - Joint training;
  - Terrorism and CIT implications;
  - ATMs physical security;
  - Inhibition of electronic signals.
