- Standardization to support legislation
- Policy for assessment of conformity



# **New Approach Directives**

#### **Present Applications**

 Low voltage equipment • Simple vessels • Toys •
Electromagnetic compatibility • Construction products •
Machinery • Lifts • Personal protective equipment • Nonautomatic weighting instruments • Medical devices •
Active implantable medical devices • Gas appliances •
New hot water boilers fired with liquid or gaseous fluids (efficiency requirements) • Explosives for civil uses •
Equipment and protective systems in potentially explosive atmospheres • Recreational craft

# **New Approach Directives**

### **Essential Requirements:**

- The standards lay down the necessary elements for protecting the public interest
- Are then mandatory. Only products conforming to essential requirements may be placed on the market and put into service
- Must be applied as a function of the hazards inherent to a given product or situation



### **New Approach**

European Commission / Single Market - Regulatory Policy / Guide to the Implementation of Directives Based on New Approach and Global Approach

'Free movement of goods is a cornerstone of the single market. The mechanisms in place to achieve this aim are based on prevention of new barriers to trade, mutual recognition and technical harmonisation.'



# **New Approach**

# What does all this mean for members?

- 80% of robberies on CViT crews take place in the UK
- IBNS systems are used widely across the pavement
- Deterrent is perceived as not working in the UK
- New technology being tested
- Systems will not work without the cooperation of central banks and, preferably, legislators
- Do members want harmonization?
- What is the probability that CViT and IBNS could be included in the New Approach?



# How to get involved....

- Each member country's National Standards Body has a 'mirror group'. Contact your NSB and participate.
- Mirror groups decide the country's policy towards the various parts of the standard and mandate up to four experts to represent them on the Working Group. (WG4 rule)
- Presently 17 (out of 30) countries are not represented. Several countries send just one representative.
